(Constitutional Amendment) Provides for the election of all members of the State Board of Elementary and Secondary Education
The proposed constitutional amendment would require all members of the state Board of Elementary and Secondary Education (BESE) to be elected for four year terms concurrent with the term of the governor. The three at-large members currently appointed by the Governor would be elected effective January 12, 2016.

The constitutional amendment will be placed on the ballot at the statewide election held on November 4, 2014.
