Provides for a local referendum on the question of selecting a lessee for hospitals in Jefferson Parish

Purpose of Bill: This measure provides the requirements to lease the hospitals owed by the districts. No lease shall be entered into unless all hospital facilities in Jefferson Parish will be leased to a single lessee. The Jefferson Parish governing authority shall select two potential lessees and call an election in which the electors of Jefferson Parish shall select the lessee by the majority of votes cast.

EXPENDITURE EXPLANATION

There maybe an increase in governmental expenditures as a result in this measure.

According to an official with the Secretary of State's Office, a parish wide election in Jefferson Parish would cost approximately \$300,000. This proposition election would be held on a date that already has scheduled elections. Adding one more item to an existing election would have minimal impact on the cost of the election. It would affect the amount each local government entity having ballot items would pay because costs are prorated based on the number of ballot items.

According to officials with the Jefferson Parish hospital service districts, additional expenditures may be incurred for public education in connection with the election.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
