#### Abstract

AN ACT To amend and reenact R.S. 17:3048.1(A)(1)(b)(ii)(bb), (c)(ii)(bb), and (d)(ii)(bb), relative to the Taylor Opportunity Program for Students; to provide with respect to the method used to calculate the grade point average required for program awards; to provide that a five-point scale shall be used to calculate the grade point average for certain honors and gifted and talented courses; and to provide for related matters.


Be it enacted by the Legislature of Louisiana:
Section 1. R.S. 17:3048.1(A)(1)(b)(ii)(bb), (c)(ii)(bb), and (d)(ii)(bb) are hereby amended and reenacted to read as follows:
§3048.1. Program awards; eligibility; amounts; limitations; funding; administration
A.(1) As part of the Louisiana Taylor Opportunity Program for Students, the state shall financially assist any student who enrolls on a full-time basis in a public college or university in this state or a regionally accredited independent college or university in the state that is a member of the Louisiana Association of Independent Colleges or Universities, hereafter in this Chapter referred to collectively as "eligible colleges or universities", to pursue an academic undergraduate degree or, as provided by this Subsection, skill or occupational training as defined by the Board of Regents, including a vocational or technical education certificate or diploma program or a nonacademic undergraduate degree, and who meets the qualifications of Subparagraph (b), (c), or (d) of this Paragraph and all of the applicable following qualifications:

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

Nevers (SB 98)
Present law provides that the minimum cumulative grade point average (GPA) required for a student to be eligible for a Taylor Opportunity Program for Students (TOPS) Opportunity, Performance, or Honors award shall be calculated using only the grades obtained by the student in courses contained in the TOPS core curriculum as prescribed by present law.

Proposed law retains present law.
Present law provides that, beginning with students graduating in the 2017-18 school year, TOPS GPA calculation shall utilize a five-point scale for grades earned in certain Advanced Placement (AP), International Baccalaureate (IB), gifted courses, and dual enrollment courses as approved by the Board of Regents and the State Board of Elementary and

Secondary Education (BESE). Proposed law retains present law and additionally provides that the TOPS GPA calculation shall also utilize a five-point scale for honors courses and talented courses.
