Provides relative to TOPS-Tech Early Start award. (gov sig)

Proposed law expands the use of the award so that it may be used to fund any technical or applied course leading to an Industry Based Certification, a Certificate of Applied Sciences, and a Certificate of Technical Sciences at a Louisiana public postsecondary education institution when such certification or certificate is approved by the Workforce Investment Council as meeting the following requirements: (1) Is identified by the Occupation Forecasting Conference as a credential for an occupation in top demand in Louisiana. (2) Is recognized by the State Industry-Based Certification Leadership Council. Proposed law eliminates the requirement that credentials be approved by BESE and by the Board of Supervisors of Community and Technical Colleges. Proposed law eliminates the requirement that the student must have at least the minimum scores required to pass the mathematics and English portions of the graduation exit exam established by BESE. Proposed law requires that Louisiana Student Financial Aid Commission (LASFAC), rather than the Board of Regents, issue the report currently required by present law. Effective upon governor's signature.

The changes stating that a TOPS-Tech Early Start Award may be used to fund any technical or applied course leading to an Industry Based Certification, a Certificate of Applied Sciences, and a Certificate of Technical Sciences are technical in nature. These changes do not alter any current program requirements according to LOSFA. The deletion of the requirements that participants in the program pass the mathematics and English portions of the graduation exit exam (GEE) are also technical changes. The GEE (including obsolete math and English tests) are no longer administered and were replaced by individual end-of-course exams.
