| Security District; to provide for governance; to provide for a flat fee per parcel of     |
| land; to provide for election dates; to provide for an effective date; and to provide for |
| related matters.  |
| Notice of intention to introduce this Act has been published.                             |
| Be it enacted by the Legislature of Louisiana:  |
| Section 1. R.S. 33:9091.14 (D), (F)(1), (2) and (3)(c) are hereby amended and             |
| reenacted to read as follows:   |
| §9091.14. Mid-City Security District  |
| D. Governance. (1) The district shall be governed by a five seven-member                  |
| board of commissioners, referred to in this Section as the "board". The board shall       |
| be composed as follows:   |
| (a) The Mid-City Neighborhood Organization shall appoint two four                         |
| members, one of whom shall be from the City Park Triangle.                                |
| (b) The Parkview Neighborhood Association shall appoint one member.                       |
| (c) The two members of the governing authority of the city of New Orleans                 |

| 24 | three hundred dollars and. For improved residential parcels subject to a special         |

| 19 | vetoed by the governor and subsequently approved by the legislature, this Act shall become    |

## DIGEST

Peterson (SB 587)

<u>Present law</u> provides for the district to be governed by a five-member board of commissioners.

<u>Proposed law</u> retains <u>present law</u> and provides for an increase on the board of commissioners <u>from</u> five to seven members.

<u>Present law</u> provides for one member to serve an initial term of one year, two members shall serve initial terms of two years; and two members shall serve an initial term of three years, as determined by lot at the first meeting of the board held after the members are appointed.

Proposed law retains present law and provides for a flat fee not to exceed \$150 per year for

improved residential parcels subject to a special assessment, and \$100 for unimproved residential or commercial parcels. <u>Proposed law</u> further provides for a flat fee per commercial parcels to not exceed \$375 for each municipal address assigned to an improved commercial parcel.

<u>Proposed law</u> requires an election to be held at the same time as a regularly scheduled municipal, state, or federal election when the parcel fee is to be renewed.

Effective upon signature of the governor or lapse of time for gubernatorial action.
