Proposed law prohibits a health coverage plan from denying coverage for a medically necessary treatment prescribed by a physician and agreed to by a fully informed insured or that person's legal health care proxy based solely on an insured's life expectancy or the fact that the insured is diagnosed with a terminal condition. Proposed law prohibits a health benefit paid directly or indirectly with state funds from denying coverage for medically necessary treatment. Proposed law provides that refusing coverage for medically necessary treatment to be rendered to an insured based solely on the insured's life expectancy or the fact that the insured is diagnosed with a terminal condition shall be a violation of proposed law. Proposed law provides for definitions.
