PHYSICIANS. Provides for an automatic suspension of a physician's license. (gov sig)

1	AN ACT
2	To enact R.S. 37:1287.2, relative to a physician's license; to provide for the automatic
3	suspension of a physician's license; to provide for a hearing; to provide for an
4	effective date; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 37:1287.2 is hereby enacted to read as follows:
7	§1287.2. Automatic suspension of a license
8	A. Any license or permit issued by the board to a physician shall be
9	automatically suspended upon a physician's conviction or entry of a plea of
10	guilty or nolo contendere to a felony that constitutes a crime of violence as
11	defined in R.S. 14:2, arises out of the practice of medicine, or arises out of the
12	billing for health care services.
13	B.(1) The automatic suspension provided for in this Section shall remain
14	in effect from the date of conviction or plea until the conclusion of the
15	administrative proceedings and issuance of a final decision, consent order or
16	other order by the board pursuant to the Administrative Procedure Act.
17	(2) An individual whose license has been automatically suspended may

request an expedited hearing before the board. The hearing required in

Paragraph A(1) of this Section shall begin no later than ninety days from the

date of the board's receipt of such request.

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature

vetoed by the governor and subsequently approved by the legislature, this Act shall become

by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

<u>Proposed law</u> provides any board issued license or permit to a physician shall be automatically suspended upon a physician's conviction or entry of a plea of guilty or nolo contendere to a felony that constitutes a crime of violence as defined in <u>present law</u>, arises out of the practice of medicine, or arises out of the billing for health care services.

<u>Proposed law</u> provides the automatic suspension shall remain in effect from the date of conviction or plea until the conclusion of the administrative proceedings and issuance of a final decision, consent order or other order by the board pursuant to the Administrative Procedure Act.

<u>Proposed law</u> provides an individual whose license has been automatically suspended may request an expedited hearing before the board.

Effective upon signature of the governor or lapse of time for gubernatorial action.
