12 **account solely for the deposit and expenditure of funds for retiree legacy costs as**
13 **provided in R.S. 17:1224.**"

14 AMENDMENT NO. 6

15 On page 4, at the end of line 6, delete "special"

16 AMENDMENT NO. 7

17 On page 4, line 7, between "students" and "as provided" insert "**having special**
18 **characteristics or needs**"

19 AMENDMENT NO. 8

20 On page 4, delete lines 21 and 22, and insert "**system for expenditure for school system**
21 **costs as provided in Paragraph (A)(3) of this Section, excluding retiree legacy costs and**
22 **bonded indebtedness.**"

23 AMENDMENT NO. 9

24 On page 5, line 4, between "and" and "goals" change "accountability" to "performance"

25 AMENDMENT NO. 10

26 On page 5, delete lines 12 and 13.

27 AMENDMENT NO. 11

28 On page 5, delete lines 14 and 15, and insert the following:

29 **"(9) Identify, recruit, retain, and train the best principals."**

2 On page 5, at the beginning of line 16, change "**(b)**" to "**(10)**"

3 AMENDMENT NO. 13

4 On page 5, line 16, change "**providing**" to "**provide**"

5 AMENDMENT NO. 14

6 On page 5, at the beginning of line 29, change "**(c) Processing and reporting**" to
7 "**(11) Process and report**"

22 **salaries. The duration of management contracts entered into prior to July 1, 2017,**
23 **shall not exceed two years. The duration of management contracts entered into on or**
24 **after July 1, 2017, shall be no more than five years and no less than one year. A**
25 **principal's management contract may be terminated for failure to meet the**
26 **performance goals specified in the contract and for willful neglect of duty,**
27 **incompetency, dishonesty, or immorality."**

28 AMENDMENT NO. 21

29 On page 7, line 1, change "**three**" to "**five**"

30 AMENDMENT NO. 22

31 On page 7, delete line 9, and insert the following:

32 **"E. Charter schools located within the geographic boundaries of the**
33 **large school system shall be included as an"**

35 On page 7, between lines 11 and 12, insert the following:

1 **"F. If a student's parent or legal guardian fails to choose a school**
2 **through the enrollment system, the large school system shall assign the student**
3 **to a school with excess capacity. In no case shall a student be assigned to, or**
4 **required to attend, a charter school, a school under the jurisdiction of the**
5 **Recovery School District, or a school outside the jurisdiction of the large school**
6 **system in which he resides."**

9 **"(5) Ensuring a safe workplace environment for teachers and other**
10 **school personnel."**

5 On page 10, between lines 2 and 3, insert the following:

6 "§137. Legacy costs; determination and payment

7 A. All public schools eligible to enroll students who reside within the
8 geographic boundaries of the large school system shall pay the large school
9 system a per-pupil amount for reimbursement of legacy costs. This per-pupil
10 amount shall be determined by an independent third-party expert selected by
11 the superintendent of the large school system from a list of three names
12 submitted by the state superintendent of education. The school system may
13 retain the legacy costs owed by each school from the per-pupil amount
14 established for students attending the school.

15 B. Every charter school that enrolls students who reside within the
16 geographic boundaries of the large school system is subject to the provisions of
17 this Section and shall remit the amount of the legacy costs determined for the
18 charter school to the large school system."
