HOUSE RESOLUTION NO. 78

PUBLIC SFTY/CORRECT DEPT: Directs the Department of Public Safety and Corrections to review the feasibility of expanding the workforce development sentencing program

A RESOLUTION

2 To direct the Department of Public Safety and Corrections to study the feasibility and make 3 recommendations relative to the expansion of the workforce development sentencing 4 program to include additional judicial district reentry courts. 5 WHEREAS, the Department of Public Safety and Corrections workforce 6 development sentencing program was created pursuant to Act No. 399 of the 2012 Regular 7 Session of the Legislature; and 8 WHEREAS, the program requires the department in conjunction with the reentry 9 division of district courts to identify eligible candidates who are suitable for the workforce 10 development sentencing program and to assist the offenders in becoming more productive 11 members of society upon their return to the community, thereby reducing recidivism and 12 improving public safety; and 13 WHEREAS, since the enactment of Act No. 399 of the 2012 Regular Session of the 14 Legislature, there are currently four judicial district courts that are authorized to assign a 15 certain division of the court as a reentry division of court, the Nineteenth Judicial District 16 Court, the Twenty-Second Judicial District Court, the Eleventh Judicial District Court, and 17 the Criminal District Court for the parish of Orleans; however, several judicial district courts 18 have expressed their interest in expanding the workforce development sentencing program 19 to their districts; and

1 WHEREAS, the program is conducted at the Louisiana State Penitentiary, where 2 there are currently one hundred twenty slots available for offenders, of which one hundred 3 nine are filled; and 4 WHEREAS, it is anticipated that by the end of 2014, there will be an additional fourteen slots that will become available in increments as offenders graduate from the 5 6 program throughout the year; and 7 WHEREAS, there are multiple judicial districts that have expressed an interest in 8 participating in the program; however, due to the limited availability for housing the 9 offenders at the Louisiana State Penitentiary, those judicial districts are restricted from creating reentry courts and providing the opportunity to offer rehabilitation to offenders in 10 11 their districts. 12 THEREFORE, BE IT RESOLVED that the House of Representatives of the Legislature of Louisiana does hereby direct the Department of Public Safety and Corrections 13 14 to study the feasibility and make recommendations relative to the expansion of the 15 workforce development sentencing program to include additional judicial district reentry 16 courts. 17 BE IT FURTHER RESOLVED that the Department of Public Safety and Corrections 18 make a written report to the House Committee on Judiciary detailing their findings no later 19 than January 1, 2015. 20 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
