**HOUSE BILL NO. 1233**

TRAFFIC/VIOLATIONS: Prohibits municipalities from issuing citations on an interstate highway unless at least one-half linear mile in each direction of the travel lane of the interstate highway is included within the city limits

1 AN ACT 2 To enact R.S. 32:398.1(D), relative to issuance of traffic citations; to prohibit municipalities 3 from issuing traffic citations on an interstate highway under certain circumstances; 4 and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 32:398.1(D) is hereby enacted to read as follows: 7 §398.1. Traffic citations; form; issuance 8 9 D. Law enforcement agencies of a municipality are prohibited from issuing 10 speeding citations to a person driving on an interstate highway unless at least one-11 half linear mile in each direction of the travel lane of the interstate highway is within 12 the city limits of the municipality. Bridges, overpasses, on ramps, and off ramps are 13 excluded when determining whether one-half mile of the interstate highway is within 14 the city limits.

**Abstract:** Prohibits law enforcement agencies of a municipality from issuing speeding citations on an interstate highway unless at least one-half linear mile in each direction of the interstate is within the city limits.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> prohibits law enforcement agencies of a municipality from issuing speeding citations to drivers operating on the interstate highway unless at least one-half linear mile in each direction of the travel lane of the interstate highway is within the city limits of the municipality. Excludes bridges, overpasses, on ramps, and off ramps when determining whether a half mile of the interstate highway is within the city limits.

## Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Transportation, Highways</u> and <u>Public Works</u> to the <u>original</u> bill.

- 1. Made technical changes.
- 2. Changed "traffic citations" to "speeding citations".
- 3. Clarified that only the travel lane of the interstate highway is considered in determining whether a half mile of the interstate is within city limits.
- 4. Excluded bridges, overpasses, on ramps, and off ramps when determining whether a half mile of the interstate highway is within the city limits.
