TAX/AD VALOREM TAX RE +\$4,800 LF EX See Note Page 1 of 1 Changes requirements for public hearings at which millage adjustments are considered by certain taxing authorities

**Purpose of Bill:** This bill requires that the governing authority of St. Tammany Parish approve any proposed increase in a millage for the ensuing year above the amount levied for that millage in the immediately preceding year for those non-elected taxing authorities within the parish that are subject to the annual levy provisions related to Ad Valorem Taxes (R.S. 47:1705). This approval by the governing authority must take place before any vote to approve such increase may be taken by the taxing authority.

## **EXPENDITURE EXPLANATION**

This bill may increase local expenditures by an average of \$4,400 annually.

In order to assess proposed millage increases from approximately 40 taxing authorities within the parish, the St. Tammany Parish Finance Director estimates the Parish Council may have to hold an additional 4 meetings annually at a cost of \$1,000 per meeting with a 5% increase in each subsequent year.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
