MOTOR VEHICLES. Authorize university logo to be placed on a driver's license or identification card issued by the office of motor vehicles. (1/1/15)

1	AN ACT
2	To enact R.S. 32:412(M) and R.S. 40:1321(M), relative to drivers' licenses and special
3	identification cards; to provide for the exhibition of the logo of any Louisiana
4	university on a driver's license and special identification card; to authorize collection
5	of a university logo fee, if any, as established by any Louisiana university for the use
6	and display of its logo; to provide for the disbursement of such logo fees collected
7	to the foundation of such universities; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 32:412(M) is hereby enacted to read as follows:
10	§412. Amount of fees; credit or refund; duration of license; veteran designation;
11	university logo; "I'm a Cajun" designation; disbursement of funds;
12	renewal by mail or electronic commerce of Class "D" or "E" drivers'
13	licenses; disposition of certain fees; exception

15	M.(1) Upon request and payment of a university logo fee, if any, as
16	established by any Louisiana university for the use and display of its logo, the
17	logo of the university shall be exhibited in color on the driver's license

Mills (SB 138)

<u>Proposed law</u> provides for exhibition of any Louisiana university's logo in color on a driver's license or identification card, upon request and payment of a university logo fee, if any, established by such university for the use and display of its logo.

<u>Proposed law</u> provides for collection of such university logo fees by the Department of Public Safety and Corrections (DPSC) and quarterly disbursement of monies collected to the foundation of such universities.

<u>Proposed law</u> requires the DPSC to establish rules and regulations as necessary for implementation.

<u>Proposed law</u> requires participating university foundation to pay implementation costs.

Effective January 1, 2015.
