1 AN ACT

2 To amend and reenact R.S. 40:964(Schedule IV)(B)(1) and to enact R.S. 40:964(Schedule  
3 II)(E)(3), (Schedule III)(B)(15), (E)(29.1) and (53.1), and (Schedule IV)(B)(1.5) and  
4 (D)(13), relative to the Uniform Controlled Dangerous Substances Law; to add  
5 certain substances to Schedules II, III, and IV; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 40:964(Schedule IV)(B)(1) is hereby amended and reenacted and  
8 R.S. 40:964 (Schedule II)(E)(3), (Schedule III)(B)(15), (E)(29.1) and (53.1), and (Schedule  
9 IV)(B)(1.5) and (D)(13) are hereby enacted to read as follows:

10 §964. Composition of schedules

11 Schedules I, II, III, IV, and V shall, unless and until added to pursuant to R.S.  
12 40:962, consist of the following drugs or other substances, by whatever official  
13 name, common or usual name, chemical name, or brand name designated:

E. Anabolic steroids and muscle building substances. Unless specifically excepted or unless listed in another schedule, any material, compound, mixture, or preparation, containing any quantity of the following substances, including its salts, esters, ethers, isomers, and salts of isomers whenever the existence of such salts, esters, ethers, isomers, and salts of isomers is possible within the specific chemical designation. The term "anabolic steroid" means any drug or hormonal substance, chemically and pharmacologically related to testosterone, other than estrogens, progestins, corticosteroids, and dehydroepiandrosterone that promote muscle growth and include the following:

(29.1) Methasterone (2,17 $\alpha$ -dimethyl-5 $\alpha$ -androstan-17 $\alpha$ -ol-3-one)
