CIVIL PROCEDURE EG1 NO IMPACT See Note Page 1 of 1  
 Provides relative to service of process. (gov sig)

Present law relative to service of citation and process in civil case provides generally that, if service of citation is not waived, then such service shall be requested within 90 days of commencement of the action.

Proposed law adds that if service of citation is not waived, then a request for service of citation upon the defendant shall be considered timely if requested on the defendant within the time period provided in present law, notwithstanding insufficient or erroneous service.
