Provides relative to hospital notaries.(8/1/14)

<u>Present law</u> provides that the director of specific hospital service district hospitals may appoint not more than two employees of the hospital as ex officio notaries public. <u>Present law</u> provides that such ex officio notaries may exercise the functions of a notary public only to perform certain notary tasks and activities. <u>Proposed law</u> expands and amends language to make the capacity of hospital directors to appoint an ex officio notary public to include all hospital service district hospitals. <u>Proposed law</u> provides that ex officio notaries appointed under this statutory authority may only exercise notary tasks and activities limited to matters within the official business functions of the hospital.
