SENATE CONCURRENT RESOLUTION NO. 134

SCHOOLS. Requests BESE to study and report to the legislature regarding current student discipline policies and possible changes to these policies.

1	A CONCURRENT RESOLUTION
2	To urge and request the State Board of Elementary and Secondary Education to examine and
3	consider the status of school suspensions and expulsions, as well as plans to revise
4	current school discipline policies in response to the "Supportive School Discipline
5	Initiative" launched by the United States departments of education and justice.
6	WHEREAS, the stated vision of the Louisiana Department of Education is "to ensure
7	all students are on track to attain a college degree or succeed in a professional career."; and
8	WHEREAS, the state's goal of preparing every student for college and careers cannot
9	be attained without providing a safe and secure learning environment that is conducive to
10	effective teaching and learning; and
11	WHEREAS, heavy reliance on suspensions and expulsions to create a positive school
12	climate is clearly not the answer, as it fails to help a student develop the skills and strategies
13	needed to improve behavior and has a tremendous academic cost in lost learning time; and
14	WHEREAS, exclusionary school discipline practices are statistically proven to
15	disproportionately impact students of color and students with disabilities; and
16	WHEREAS, suspended students are less likely to graduate on time, are more likely
17	to be suspended again, repeat a grade, or drop out of school and enter the juvenile justice
18	system; and

1 WHEREAS, removing a student from the classroom should be a last resort in 2 addressing unacceptable behavior and the optimal way to intervene and improve academic 3 and societal outcomes for these students is to identify and target the underlying causes of 4 misbehavior; and WHEREAS, to assist schools, school districts, and states in addressing this serious 5 issue, the United States departments of education and justice collaboratively launched the 6 7 "Supportive School Discipline Initiative" to support the use of school discipline practices 8 that foster safe, supportive, and productive learning environments, while keeping students 9 in school; and 10 WHEREAS, the role of the Initiative has been to provide schools with effective 11 alternatives to suspensions and expulsions as a primary means of disciplining students, with 12 a focus on reducing the disproportionality for students of color and students with disabilities; 13 and 14 WHEREAS, in January, 2014, the U.S. Department of Education released guidance to state, district, and school-level officials outlining principles and strategies for improving 15 school climate and school discipline practices. 16 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 17 urge and request the State Board of Elementary and Secondary Education to examine and 18 19 consider the status of school suspensions and expulsions, as well as plans to revise current school discipline policies in response to the "Supportive School Discipline Initiative" 20 21 launched by the United States departments of education and justice. BE IT FURTHER RESOLVED that the board submit a written report to the Senate 22 Committee on Education, the House Committee on Education, and the Senate Select 23 Committee on Women and Children, not later than March 1, 2015. 24
