SCHOOLS. Provides relative to student application and enrollment procedures in the Recovery School District and certain other school systems. (gov sig)

1	AN ACT
2	To enact R.S. 17:221.1, relative to the Recovery School District and certain other public
3	school systems; to provide relative to student enrollment; to provide relative to
4	school systems with an enrollment process which utilizes a single application; to
5	provide relative to application and enrollment procedures and time lines; to provide
6	relative to notification of school enrollment information; to provide for effectiveness;
7	and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 17:221.1 is hereby enacted to read as follows:
10	§221.1. Student enrollment; school systems utilizing a single application
11	process; requirements and time lines
12	A. The Recovery School District and any other public school system that
13	establishes an enrollment process through which students may apply to multiple
14	schools utilizing a single application shall comply with the following:
15	(1) The school system shall publish current information which provides
16	clear instructions regarding the application and selection process, including all
17	applicable time lines. This information shall also include a list of all schools

1	within the school system that utilize the single application process to enroll
2	students and those schools that do not participate in the single application
3	process, thus requiring each student seeking enrollment to the school to submit
4	a separate application.
5	(2) The school system shall develop time lines and procedures that
6	require each school that does not participate in the single application process
7	to complete its application and registration process at least thirty days prior to
8	the application deadline for schools that utilize the single application to enroll
9	students.
10	(3) The school system shall require each school that does not utilize the
11	single application process to submit a list of all students enrolled in the school
12	to the school system at the conclusion of the school's application and
13	registration period.
14	B. The provisions of this Section shall be fully implemented and utilized
15	to enroll students in the public school systems to which it is applicable beginning
16	with the 2015-2016 school year.
17	Section 2. This Act shall become effective upon signature by the governor or, if not
18	signed by the governor, upon expiration of the time for bills to become law without signature
19	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
20	vetoed by the governor and subsequently approved by the legislature, this Act shall become
21	effective on the day following such approval.

Morrell (SB 683)

<u>Proposed law</u> provides with respect to the Recovery School District and other public school systems that establishes an enrollment process through which a student may apply to multiple schools utilizing a single application as follows:

(1) Requires the school system to publish current information which provides clear instructions regarding the application and selection process, including all applicable time lines. Provides that this information shall also include a list of all schools within the school system that utilize the single application process to enroll students and those schools that do not participate in the single application process, thus requiring

each student seeking enrollment to the school to submit a separate application.

- (2) Requires the school system to develop time lines and procedures that require each school that does not participate in the single application process to complete its application and registration process at least thirty days prior to the application deadline for schools that utilize the single application to enroll students.
- (3) Provides that the school system shall require each school that does not utilize the single application process to submit a list of all students enrolled in the school to the school system at the conclusion of the school's application and registration period.
- (4) Provides that the provisions of <u>proposed law</u> shall be fully implemented and utilized to enroll students in the public school systems to which it is applicable beginning with the 2015-2016 school year.

Effective upon signature of the governor or lapse of time for gubernatorial action.
