HOUSE RESOLUTION NO. 149

CRIMINAL/JUSTICE: Directs the Louisiana State Law Institute to evaluate Louisiana's
"stand your ground" laws

1 A RESOLUTION

2 To direct the Louisiana State Law Institute to evaluate Louisiana's "stand your ground" laws,
3 compare them to the laws of other states on this issue, and make recommendations
4 regarding any changes to Louisiana law resulting from that evaluation.

5 WHEREAS, the common law principle of the "castle doctrine" means that
6 individuals have the right to use reasonable force, including deadly force, to protect
7 themselves against an intruder in their home; and

8 WHEREAS, this principle has been codified and expanded by state legislatures; and

9 WHEREAS, laws in at least twenty-two states provide that there is no duty to retreat
10 an attacker in any place in which one is lawfully present; and

11 WHEREAS, for over one hundred years, Louisiana law has provided that the use of
12 force or the commission of a homicide is justified if it is committed in self-defense or is
13 committed to prevent a homicide or violent offense committed against another person; and

14 WHEREAS, Act No. 141 of the 2006 Regular Session of the Legislature introduced
15 a new concept into Louisiana law by enacting R.S. 14:19(c) and 20(C), known as Louisiana's
16 "stand your ground law" which provides that, "[a] person who is not engaged in unlawful
17 activity and who is in a place where he or she has a right to be shall have no duty to retreat
18 before using [deadly force, force, or violence] and may stand his or her ground and meet
19 force with force."; and

1 WHEREAS, it is appropriate that the laws regarding "stand your ground" be
2 reviewed in comparison to the laws of other states and with respect to court decisions
3 interpreting those laws.

4 THEREFORE, BE IT RESOLVED that the House of Representatives of the
5 Legislature of Louisiana does hereby direct the Louisiana State Law Institute to evaluate the
6 provisions of Louisiana law regarding "stand your ground" provisions, as well as the
7 provisions of law from other states regarding this issue, and make any recommendations
8 regarding any changes to those laws which may result from that evaluation.

9 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
10 director of the Louisiana State Law Institute.
