Authorizes the Port of South Louisiana, the Lafourche Basin Levee District, and the Pontchartrain Levee District to enter a cooperative endeavor agreement to authorize the exercise of combined police protection. (8/1/14) (2/3-CA6s43(2)) Purpose of Bill: This bill provides that the Port of South Louisiana, the Lafourche Basin Levee District, and the Pontchartrain Levee District may enter into a cooperative endeavor agreement to authorize the exercise of combined police protection. It requires that officers shall be commissioned as peace officers by the Department of Public Safety and Corrections. Should the entities choose to enter into such an agreement, the measure further provides that the governing authority of each entity shall appoint two members to serve as members of an oversight committee, which may employ a chief law enforcement officer. In addition, this bill creates the position of executive director and assistant executive director for the Lafourche Basin Levee District to be appointed by the board. Both positions shall be full-time unclassified employees of the board who shall be paid compensation in an amount to be determined by the board, comparable to like positions with levee districts throughout the state.

## **EXPENDITURE EXPLANATION**

This measure may increase local government expenditures by approximately \$2.5 Million in the first year of operation and an average of approximately \$2 Million in the following years. This increase is dependent upon the terms of a cooperative endeavor agreement that may be entered into by the Port of South Louisiana, the Lafourche Basin Levee District, and the Pontchartrain Levee District.

Because this measure is permissive, the total impact on government expenditures will depend upon whether these entities decide to enter into a cooperative endeavor agreement, and the specific terms of the agreement.

Officials with the Pontchartrain Levee District estimate that expenditures will increase by \$2,195,000 to provide expanded police protection. These costs include hiring 12 additional officers, a chief of police, support staff, equipment, etc. Costs are estimated to be less in subsequent years.

In addition, the Lafourche Basin Levee District will be responsible for appointing the executive director and assistant executive director. Salaries and related benefits for these positions may be approximately \$300,000.

At the time this fiscal note was published, we had not received any information from the Port of South Louisiana.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
