2	To amend and reenact R.S. 34:3493(A)(1), 3495(A), (C), (D), (F), and (G) and to enact R.S.
3	34:3499.1, relative to the Louisiana International Deep Water Gulf Transfer
4	Terminal Authority; to provide for jurisdiction; to provide for changes in the
5	coordinates; to provide for an executive board; to provide for the legislative auditor;
6	to provide for contracting parties; to provide for financial compliance; and to provide
7	for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 34:3493(A)(1), 3495(A), (C), (D), (F), and (G) are hereby amended
10	and reenacted and R.S. 34:3499.1 is hereby enacted to read as follows:
11	§3493. Jurisdiction; domicile

A.(1) The Louisiana International Deep Water Gulf Transfer Terminal Authority shall have only that exclusive jurisdiction as provided herein over a structure, a series of structures, or a facility constructed after July 1, 2008, at the lower end of the east bank at Southwest Pass in Plaquemines Parish on state owned property, beginning at latitude 28.934856 degrees; longitude 89.398368 degrees then east to latitude 28.929035 degrees; longitude 89.390547 then south to latitude 28.915113 degrees; longitude 89.403934 degrees then west to latitude 28.920933 degrees; longitude 89.411755 degrees and then back to point of beginning described as follows to wit: beginning at a point having latitude 28.953797 degrees north and longitude 89.316072 degrees west; thence proceed to a point having latitude 28.941817 degrees north and 89.316192 degrees west; thence proceed to a point having latitude 28.918486 degrees north and 89.336992 degrees west; thence proceed to a point having latitude 28.918692 degrees north and longitude 89.349631 degrees west; thence proceed to a point having latitude 28.940650 degrees north and longitude 89.353161 degrees west; thence proceed to a point having latitude 28.953931 degrees north and 89.324425 degrees west; thence proceed to the point of beginning and designed to accommodate deep draft

7	§3495. Duties of board; officers; rules; meetings; quorum
8	A. The board of commissioners shall be the governing body of the authority
9	with full power to promulgate rules and regulations for the maintenance and
10	operation of said authority but may defer certain matters to the executive board
11	provided for in Subsection C of this Section for consideration and action. Any
12	action taken by the executive board shall be ratified by the board of
13	commissioners. Prior to the adoption of any rule or regulation for the maintenance
14	and operation of said authority, such rule or regulation shall be subject to the
15	approval of the House and Senate committees on transportation, highways, and
16	public works and the Joint Legislative Committee on the Budget.
17	* * *
18	C. The commissioners shall elect a president, two vice presidents, a
19	secretary, and a treasurer from among themselves the members of the board of
20	commissioners to serve for a term of two years and who shall constitute the
21	executive board.
22	D. The executive director, as shall be chosen by the board of commissioners:
23	shall be the secretary of the board.

25	F. The board of commissioners or the executive board shall meet at least
26	once every ninety days, or upon the written request of three members, or upon the
27	written request of the president. The board may, upon the affirmative vote of a
28	majority of its members, extend the ninety-day time interval between regular
29	meetings.

G. All matters to be acted upon by the board of commissioners or the

1 **executive board** shall require the affirmative vote of a majority of the board, with 2 the exception that the affirmative vote of not less than ten commissioners shall be 3 required to select the executive director. 4 §3499.1. Audit and inspection of records 5 A. Any contract, agreement, memorandum of understanding, or 6 7 cooperative endeavor agreement entered into in order to carry out the purposes 8 of this Chapter by the authority with any other party, whether public or 9 private, shall require the contracting party to tender their annual financial 10 audit, including all documents required to be submitted to federal regulators, 11 to the authority for each year the agreement is in effect. 12 B. Any party to a contract listed in Subsection A of this Section shall 13 allow the legislative auditor, the legislative auditor's authorized representatives, and the state of Louisiana, independently and with or through the authority, to 14 15 inspect and audit all data and financial records of the contracting party related to its performance with respect to the contract, in accordance with the 16 17 provisions set forth in R.S. 24:513 et seq. 18 C. The rights of inspection and audit set forth in this Section shall commence as of the date of the contract and shall continue until four years have 19 20 elapsed from the date the contract is terminated. 21 Section 2. This Act shall become effective upon signature by the governor or, if not 22 signed by the governor, upon expiration of the time for bills to become law without signature 23 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 24 vetoed by the governor and subsequently approved by the legislature, this Act shall become 25 effective on the day following such approval.
