**Purpose of Bill:** This measure would provide that the members of the Lafayette Parish School Board be elected at gubernatorial elections instead of congressional elections. This measure would also provide that the members of the school board elected at the congressional elections in 2014 shall serve five year terms, in order to facilitate moving future elections from congressional to gubernatorial.

## **EXPENDITURE EXPLANATION**

There is an indeterminate effect on local government expenditures due to this measure.

According to an official with the Secretary of State's office, statewide elections have very little additional cost; therefore, changing the Lafayette Parish School Board election from a congressional election to a gubernatorial election would have little effect on local government expenditures. However, there may be some cost savings, but this cannot be determined at the present time.
