1	AN ACT
2	To enact R.S. 36:8.1, relative to reporting requirements of various state agencies of the
3	executive branch; to require annual quarterly reports to the legislature of all civil,
4	legal actions filed by an agency; to provide for the content of such reports; to provide
5	exceptions thereto; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 36:8.1 is hereby enacted to read as follows:
8	<u>§8.1. Litigation oversight; reports to the legislature</u>
9	A.(1)(a) The head of each agency shall make and publish an annual report
10	to the legislature containing a list of all civil actions brought in a court of law by the
11	agency as a named party plaintiff.
12	(b) The attorney general shall make and publish an annual report to the
13	legislature containing a list of all civil actions brought in a court of law by the state
14	of Louisiana as a named party plaintiff.
15	(2) Each such report shall include all cases instituted, pending, or concluded
16	during the preceding calendar year and shall:
17	(a) Contain the names of all parties appearing as plaintiffs at any time during
18	the litigation and all parties named as defendants at any time during the litigation as
19	they appear on the pleadings, the court which has jurisdiction over the matter, the
20	docket number, the cause of action being averred, and the relief being sought.
21	(b) Indicate the current status of the case, including whether the case has
22	been heard on the merits, whether there is a final judgment therein and, if so, an
23	indication if the final judgment was determined on a procedural or substantive issue,

1	whether the case has settled prior to any final judgment, and whether an appeal has
2	been taken and, if so, if that appeal was initiated by the agency.
3	(c) List the name or names of all outside counsel representing the agency or
4	the state and the agreement of the agency or the attorney general on behalf of the
5	agency or the state, including the hourly rate of pay for the attorney or attorneys and
6	paraprofessionals or the percentage of compensation or commission or any other
7	arrangement relative to compensation, including payment of compensation by a
8	defendant.
9	(3)(a) One week before the convening of each annual legislative session, a
10	copy of the report shall be submitted by the head of each agency and the attorney
11	general to the presiding officer of each house of the legislature and shall also be
12	submitted in accordance with the provisions of R.S. 24:772.
13	(b) The presiding officer shall refer the report to the appropriate committee
14	having jurisdiction of the subject matter as provided in the rules of the respective
15	house, and any legislative committee which receives a report may conduct a hearing
16	thereon.

2	following departments or offices, including offices and agencies thereof, collectively
3	referred to in this Section as "agency":
4	(1) Department of Agriculture and Forestry.
5	(2) Department of State Civil Service.
6	(3) Department of Economic Development.
7	(4) Department of Education.
8	(5) Department of Children and Family Services, except cases brought
9	pursuant to the Children's Code and Title 46 of the Louisiana Revised Statutes of
10	<u>1950.</u>
11	(6) Department of Culture, Recreation and Tourism.
12	(7) Department of Environmental Quality.
13	(8) Department of Health and Hospitals, including, but not limited to
14	Medicaid fraud and recovery cases.
15	(9) Department of Insurance.
16	(10) Department of Justice.
17	(11) Department of Natural Resources.
18	(12) Department of Public Safety and Corrections, except cases involving
19	the Motor Vehicle Safety Responsibility Law.

29	(20) Louisiana Workforce Commission, except cases involving recovery of
30	unemployment insurance payments and workers' compensation fraud.

1	(21) Office of the governor, including the division of administration.
2	(22) Office of the lieutenant governor.
3	D. As used in this Section, the following words and phrases have the
4	following meanings ascribed to them unless the context clearly indicates otherwise:
5	(1) "Civil action" means any suit, action, or cause instituted in a court of law,
6	exclusive of criminal matters, matters involving interstate compacts, actions to make
7	executory a judgment or order of any adjudicatory body of this state, or an action
8	brought pursuant to the Enforcement of Foreign Judgments Act.
9	(2) "Court" or "court of law" means any court authorized by Article V of the
10	Constitution of Louisiana.
11	(3) "Head of each agency" means the department secretary or chief
12	administrative officer of each department of the executive branch.
13	(4) "Outside counsel" means any attorney, other than in-house counsel, who
14	is being or has been paid by any agency or the state or who is entitled to or
15	potentially entitled to compensation or a commission as a result of the legal
16	proceeding. For purposes of this Paragraph, "in-house counsel" means any attorney
17	employed by an agency, including the Department of Justice, who is eligible to
18	participate in the Louisiana State Employees' Retirement System by virtue of such
19	employment.
20	Section 2. The initial annual report required by R.S. 36:8.1(A) shall be submitted to
21	the legislature at least one week prior to the convening of the 2015 Regular Session of the
22	Legislature and shall be for the reporting period of January 1, 2014, through December 31,
23	2014.
24	Section 3. The initial quarterly report required by R.S. 36:8.1(B) shall be submitted
25	on September 1, 2014, and shall cover the period between June 1 and August 31, 2014. If,
26	however, no such civil action was filed during this period, the initial quarterly report shall
27	be submitted on or before the fourth Monday of the quarter immediately following the filing
28	of the first civil action.

1	Section 4. This Act shall become effective on July 1, 2014; if vetoed by the governor
2	and subsequently approved by the legislature, this Act shall become effective on July 1,
3	2014, or on the day following such approval by the legislature, whichever is later.
