4	rehabilitation of unemployment insurance applicants who were discharged from
5	previous employment due to drug use.
6	WHEREAS, the Legislature of Louisiana recognizes the importance of ensuring that
7	the citizens of our state are ready to work and live free of drug dependence; and
8	WHEREAS, it is in the best interest of the people of Louisiana that the population
9	of our state be free of physical and mental impairments associated with drug dependence;
10	and
11	WHEREAS, the legislature recognizes the importance of a safe and drug-free
12	workforce; and
13	WHEREAS, drug abuse creates significant workplace safety and health hazards and
14	can result in decreased productivity, more injuries on the job, and an increased cost to
15	employers; and
16	WHEREAS, in all cases of employment separation, the Louisiana Workforce
17	Commission requests the reason of separation for unemployment insurance applicants,
18	which makes the agency aware of drug-related discharges; and

1 WHEREAS, the office of behavioral health within the Department of Health and 2 Hospitals ensures care and support to improve quality of life for people with mental illness 3 and addictive disorders; and 4 WHEREAS, cooperation between the Louisiana Workforce Commission and the Department of Health and Hospitals to refer persons in need to appropriate programs will 5 6 maximize the resources of state government to create a safe and sober workforce; and 7 WHEREAS, upon successful rehabilitation, people with addictive disorders can 8 reenter the workforce of Louisiana as productive citizens. 9 THEREFORE, BE IT RESOLVED that the House of Representatives of the 10 Legislature of Louisiana does hereby urge and request the Louisiana Workforce 11 Commission, in consultation with the Department of Health and Hospitals, to develop a 12 referral process for the rehabilitation of unemployment insurance applicants who were 13 discharged from previous employment due to drug use. 14 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 15 Louisiana Workforce Commission and the Department of Health and Hospitals.
