1	AN ACT
2	To enact Chapter 1-B of Title 37 of the Louisiana Revised Statutes of 1950, to be comprised
3	of R.S. 37:24 through 27, relative to suicide assessment, intervention, treatment, and
4	management training for certain professionals; to provide relative to the Department
5	of Health and Hospitals posting on the department's official website a link to these
6	training programs; to provide relative to continuing education; to provide for certain
7	definitions, terms, conditions, and procedures; to provide for interpretation and
8	construction of laws; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Chapter 1-B of Title 37 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 37:24 through 27, is hereby enacted to read as follows:
12	CHAPTER 1-B. SUICIDE ASSESSMENT, INTERVENTION, TREATMENT,
13	AND MANAGEMENT TRAINING

15	A. In recognition of the state of Louisiana's goal in reducing the number
16	of suicides and suicide attempts each year in Louisiana, beginning January 1,
17	2015, the Department of Health and Hospitals shall offer each of the following

19	certain training programs in suicide assessment, intervention, treatment, and
20	management through posting links to such training on the department's official
21	website:
