#### BY SENATOR MURRAY AND REPRESENTATIVE MILLER

1	AN ACT
2	To amend and reenact R.S. 18:1491.7(D), 1495.5(D), and 1511.3(A), to enact R.S.
3	42:1134(A)(3), and to repeal R.S. 18:1511.2(A)(5), relative to the Supervisory
4	Committee on Campaign Finance and the Board of Ethics; to provide for the
5	approval of forms and reports by the Senate Committee on Senate and Governmental
6	Affairs and the House Committee on House and Governmental Affairs; and to
7	provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 18:1491.7(D), 1495.5(D), and 1511.3(A) are hereby amended and
10	reenacted to read as follows:
11	§1491.7. Reports; contents

13	D. The supervisory committee, by rule, may require the reporting of totals
14	of any information otherwise required to be reported, including totals of amounts
15	reported in the current report, or in the current report and other previous reports.

19	D. The supervisory committee by rule, may require the reporting of totals of
20	any information otherwise required to be reported, including totals of amounts
21	reported in the current report, or in the current report and other previous reports.

23	§1511.3. Filing of reports; forms; notice
24	A.(1) All reports required by this Chapter shall be filed with the supervisory $A(1)$
25	committee as otherwise provided in this Chapter on forms provided by the

1 supervisory committee. The supervisory committee shall prepare forms for all 2 reports required by this Chapter in conformity with the requirements of this Chapter 3 and shall cause such forms to be printed and sufficient copies thereof furnished to 4 the clerks of court and in Orleans Parish to the clerk of the criminal district court, who shall make them available to all persons required to file reports under the 5 provisions of this Chapter. All forms shall contain instructions directing the person 6 7 filing with whom to file reports. It is the intent of the legislature that the supervisory committee shall provide forms in a simple format in conformity with the 8 9 requirements of this Chapter.

10 (2) Notwithstanding the provisions of R.S. 42:1134(A)(1) or the Administrative Procedure Act, all forms required by this Chapter and all 11 12 instructions and explanation for the completion of such forms prepared by the 13 supervisory committee shall be submitted to the Senate Committee on Senate and Governmental Affairs and the House Committee on House and 14 15 Governmental Affairs for review and approval. The approval of each legislative committee shall be required prior to the utilization of a form or related 16 17 instructions or explanation pursuant to this Chapter. Upon receipt of a 18 proposed form, instructions, or explanation, the legislative committees shall meet, either separately or jointly, within sixty days to consider and act on the 19 20 proposed form, instructions, or explanation. Approval by either legislative committee, meeting separately, shall require a favorable vote of a majority of 21 22 the members present and voting, a quorum of the legislative committee being 23 present. Approval by the two legislative committees, meeting jointly, shall 24 require a favorable vote of a majority of the members of each legislative committee present and voting, each house voting separately, a quorum of the 25 joint legislative committee being present. If the proposed form, instructions, or 26 27 explanation fails to receive the approval of both legislative committees within sixty days after submission by the supervisory committee, the proposed form, 28 29 instructions, or explanation shall be withdrawn from consideration.

5	(3) Notwithstanding the provisions of Paragraph (1) of this Subsection
6	or the Administrative Procedure Act, all forms required by R.S. 42:1124,
7	1124.2, 1124.2.1, 1124.3, and 1124.5 shall be prepared and prescribed by the
8	<b>Board of Ethics as provided in this Paragraph.</b> The board shall submit all such
9	proposed forms to the Senate Committee on Senate and Governmental Affairs
10	and the House Committee on House and Governmental Affairs for review and
11	approval. The approval of each legislative committee shall be required prior
12	to the utilization of a form to satisfy the requirements of R.S. 42:1124, 1124.2,
13	1124.2.1, 1124.3, or 1124.5. Upon receipt of a proposed form, the legislative
14	<u>committees shall meet, either separately or jointly, within sixty days to consider</u>
15	and act on the proposed form. Approval by either legislative committee,
16	meeting separately, shall require a favorable vote of a majority of the members
17	present and voting, a quorum of the legislative committee being present.
18	Approval by the two legislative committees, meeting jointly, shall require a
19	favorable vote of a majority of the members of each legislative committee
20	present and voting, each committee voting separately, a quorum of the joint
21	legislative committee being present. If the proposed form fails to receive the
22	approval of both legislative committees within sixty days after submission by
23	the supervisory committee, the proposed form shall be withdrawn from
24	consideration.

26	Section 3. R.S. 18:1511.2(A)(5) is hereby repealed in its entirety.
27	Section 4. All forms, instructions, and explanations promulgated or
28	prescribed by the Board of Ethics or the Supervisory Committee on Campaign
29	Finance Disclosure prior to the effective date of this Act shall remain in effect until
30	the Board of Ethics or the Supervisory Committee on Campaign Finance Disclosure
