

SENATE BILL NO. 511

BY SENATOR HEITMEIER

1 AN ACT

2 To enact R.S. 49:191(7) and to repeal R.S. 49:191(5)(g), relative to the Department of
3 Children and Family Services; to provide for re-creation of the Department of
4 Children and Family Services and the statutory entities made a part of the department
5 by law; to provide for the effective termination date for all statutory authority for the
6 existence of such statutory entities; to provide for an effective date; and to provide
7 for related matters.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. Pursuant to R.S. 49:193, the Department of Children and Family Services
10 and the statutory entities made a part of the department by law shall be re-created effective
11 June 30, 2014, and all statutory authority therefor is continued in accordance with the
12 provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

13 Section 2. All statutory authority for the existence of the Department of Children and
14 Family Services and the statutory entities made a part of the department as re-created by
15 Section 1 of this Act shall cease as of July 1, 2019, pursuant to R.S. 49:191. However, the
16 Department of Children and Family Services may be re-created prior to such date in
17 accordance with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised
18 Statutes of 1950.

19 Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that
20 those provisions are in conflict with the provisions of this Act.

21 Section 4. R.S. 49:191(7) is hereby enacted to read as follows:

22 §191. Termination of legislative authority for existence of statutory entities; phase-
23 out period for statutory entities; table of dates

24 Notwithstanding any termination dates set by any previous Act of the
25 legislature, the statutory entities set forth in this Section shall begin to terminate their
26 operations on July first of each of the following years, and all legislative authority
27 for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of

1 July first of the following year, which shall be the termination date:

3 **(7) July 1, 2018:**

4 **(a) The Department of Children and Family Services and all statutory**
5 **entities made a part of the department by law.**

6 Section 5. R.S. 49:191(5)(g) is hereby repealed in its entirety.

7 Section 6. This Act shall become effective on June 30, 2014; if vetoed by the
8 governor and subsequently approved by the legislature, this Act shall become effective on
9 June 30, 2014, or on the day following such approval by the legislature, whichever is later.
