# ACT No. 676

HOUSE BILL NO. 1266 (Substitute for House Bill No. 955 by Representative Leger)

BY REPRESENTATIVE LEGER

1 AN ACT

2 To enact Chapter 11 of Title 48 of the Louisiana Revised Statutes of 1950, to be comprised  
3 of R.S. 48:1501, relative to regional public transportation; to provide relative to the  
4 governing boards of regional transit entities; to require the members of such boards  
5 to complete certain training requirements; to provide for responsibilities of the staff  
6 of regional planning commissions with respect to such training; to provide for  
7 effectiveness; and to provide for related matters.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. Chapter 11 of Title 48 of the Louisiana Revised Statutes of 1950,  
10 comprised of R.S. 48:1501, is hereby enacted to read as follows:

11 CHAPTER 11. REGIONAL PUBLIC TRANSPORTATION

12 §1501. Regional transit entities; board members; training

13 A. All members of a regional transit entity board shall receive and complete  
14 at least six hours of annual training, beginning the first year any such member takes  
15 office. The training shall be approved by the staff of the regional planning  
16 commission where the regional transit entity is located and shall include the duties,  
17 responsibilities, ethics, and substance of the positions held by such members.

18 B. The regional planning commission staff shall determine the eligibility of  
19 training sessions to be counted for purposes of this Section. Board members may  
20 attend training sessions covering topics that include but are not limited to transit  
21 planning; financing, operations, and design best practices; parliamentary procedure;  
22 public hearing procedure; cultural sensitivity; ethics; workforce and labor issues;  
23 public engagement; transit entity governance; and requirements of the Americans  
24 with Disabilities Act.

CODING: Words in ~~struck through~~ type are deletions from existing law; words underscored are additions.

1           C. Board members shall document their attendance of training sessions in  
 2           a written statement filed with the chief executive officer of the regional transit entity.  
 3           Each statement shall identify the date of each program attended, its subject matter,  
 4           location, sponsors, and the time spent in each program. The chief executive officer  
 5           shall submit the documentation to the regional planning commission annually.

6           D. Failure of a member to receive and complete the requisite number of  
 7           training hours in a year or to file the statement required by Subsection C of this  
 8           Section shall constitute a cause for removal of the member by his appointing  
 9           authority.

10          E. Failure of one or more members to receive and complete training as  
 11          required by the provisions of this Section shall not affect, impact, or invalidate any  
 12          action taken by a regional transit entity board.

13          F. The provisions of this Section shall apply only to persons appointed to a  
 14          regional transit entity board on and after January 1, 2015.

15          G. As used in this Section, the following terms shall have the meaning  
 16          ascribed to them in this Subsection unless the context requires otherwise:

17                 (1) "Board" means the board or commission which serves as the governing  
 18                 body of a regional transit entity.

19                 (2) "Regional transit entity" includes each area public transit system and  
 20                 regional public transit authority that administers a public transit system within a  
 21                 metropolitan area and that is created by law as a political subdivision of the state.
