The governing authority of the city of Baton Rouge, parish of 17 East Baton Rouge district is hereby authorized to impose and collect a parcel fee 18 within the district subject to and in accordance with the provisions of this Subsection. \* 19 20 (2)(a) The initial amount of the fee shall be as requested by provided in a 21 duly adopted resolution of the governing authority of the district. The initial fee 22 shall not exceed seventy-five dollars per parcel per year. 23 \*

5	enter into an agreement with the sheriff to authorize the sheriff to retain a collection

8	Section 2. This Act shall become effective upon signature by the governor or, if not
9	signed by the governor, upon expiration of the time for bills to become law without signature
10	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
11	vetoed by the governor and subsequently approved by the legislature, this Act shall become
12	effective on the day following such approval.
