**Abstract:** Exempts raw honey prepared in the home for sale from a food labeling requirement and revises provisions relative to registration by home-based food preparers for sales tax collection.

<u>Present law</u> relative to preparation of low-risk foods in the home for sale (R.S. 40:4.9) provides that home-based preparers shall affix to any food offered for sale a label which clearly indicates that the food was not produced in a licensed or regulated facility. <u>Proposed law</u> provides an exception to this labeling requirement for raw honey offered for sale if the honey is not pasteurized, filtered, or otherwise processed in such a way as to remove its natural pollen.

<u>Present law</u> (R.S. 47:305(D)(1)) exempts the sale of food for home consumption from state sales tax. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> stipulates that no individual who prepares low-risk foods in the home shall sell such foods unless he has applied for and been issued the following:

- (1) A Louisiana General Sales Tax Certificate from the Louisiana Department of Revenue (LDR).
- (2) A local sales tax certificate from the local taxing authority of any jurisdiction in which he intends to sell foods.

<u>Proposed law</u> clarifies <u>present law</u> by deleting the requirement for home-based food preparers to have a Louisiana General Sales Tax Certificate from LDR.

<u>Proposed law</u> stipulates that no individual who prepares low-risk foods in the home shall sell such foods unless he is registered to collect any local sales and use taxes that are applicable to the sale of such foods.
