Abstract: Provides that a recalled public officer who was removed from office as a member of certain municipal governing authorities is ineligible as a candidate at an election to fill a vacancy on the governing authority that is held prior to the next regularly scheduled election for members of the governing authority.

<u>Present law</u> (R.S. 18:1300.13) prohibits a public officer who has been recalled and removed from office from being appointed to succeed himself in the office from which he was recalled and removed. Further prohibits a public officer who has been recalled and removed from office from being eligible as a candidate at an election called to fill the vacancy created by the recall of the public officer.

<u>Proposed law</u> retains <u>present law</u>. Additionally provides that if the recalled public officer was removed from office as a member of the governing authority of a Lawrason Act municipality, he is ineligible as a candidate at an election to fill a vacancy on the governing authority that is held prior to the next regularly scheduled election for members of the governing authority following the recall of the public officer.
