Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 47:854(B) is hereby amended and reenacted to read as follows:

§854. Declaration of intent and purpose of Chapter

8 * * *

B. It is further the intent and purpose of this Chapter that where a dealer gives away cigars, cigarettes, or smoking tobacco for advertising or any other purpose whatsoever the same shall be taxed in the same manner as if they were sold, used, consumed, handled, or distributed in this state; however, for the taxable periods beginning on and after January 1, 2013, through December 31, 2016 December 31, 2021, this shall not be construed to include cigars or pipe tobacco, as defined and appropriately labeled in accordance with the Federal Food, Drug, and Cosmetic Act, the Family Smoking Prevention and Tobacco Control Act, also known as the Tobacco Control Act, and all applicable state laws, federal laws, and regulations, sampled on the premises of convention facilities during the Convention of the International Premium Cigar and Pipe Retailers Association.

Abstract: Extends the excise tax exemption <u>from</u> Dec. 31, 2016, <u>to</u> Dec. 31, 2021, for cigars or pipe tobacco sampled during the Convention of the International Premium Cigar and Pipe Retailers Association.

<u>Present law</u> provides for the levy of an excise tax on all cigars, cigarettes, and smoking tobacco sold, used, consumed, handled, or distributed in this state. The excise tax is required to be collected when dealers give away cigars, cigarettes, or smoking tobacco for advertising or other purposes.

<u>Present law</u> provides for an excise tax exemption until Dec. 31, 2016, for cigars or pipe tobacco sampled on the premises of convention facilities during the Convention of the International Premium Cigar and Pipe Retailers Association.

<u>Proposed law</u> extends the excise tax exemption for cigars or pipe tobacco <u>from</u> Dec. 31, 2016, <u>to</u> Dec. 31, 2021.
