Requires criminal justice agencies to annually report certain information concerning sexual assault kits and sexually-oriented criminal offenses. (gov sig)

Proposed law requires each criminal justice agency, including college and university campus police departments, to report all of the following information for the preceding calendar year no later than January 15th of each year: 1) the number of sexually-oriented criminal offenses reported, 2) the number of sexually-oriented criminal offenses investigated, and 3) the number of sexual assault collection kits submitted for analysis. Proposed law requires the LA Association of Chiefs of Police, the LA Sheriffs' Association, and the legislative auditor to transmit the information required to the chairmen of the Senate Committee on Judiciary B and the House Committee on Judiciary by March 1st of each year. Proposed law further requires the report to include the name and contact information of each criminal justice agency that failed to submit the report. Proposed law requires the LA Association of Chiefs of Police, the LA Sheriffs Association, and the legislative auditor to collaborate to develop a common reporting templet in order to submit the information to the legislative committees as required by proposed law.
