EDUCATION: Creates the Education in Alternative Settings Study Commission to study education in juvenile justice settings and in transitions between the community and juvenile justice settings

1	A CONCURRENT RESOLUTION
2	To create the Education in Alternative Settings Study Commission to study and make
3	recommendations on educational programs in juvenile justice settings and during
4	transitions between the community and juvenile justice settings.
5	WHEREAS, education is a powerful shield against delinquency and recidivism;
6	education serves as an indispensable part of positive youth development; and
7	WHEREAS, it is important that youth who are in the custody of the state's juvenile
8	justice system receive the same educational opportunities as all youth in Louisiana; and
9	WHEREAS, there are particular challenges in educating youth in juvenile justice
10	settings including high rates of special education needs and accommodating youth who enter
11	and leave juvenile justice facilities throughout the year; and
12	WHEREAS, effective educational programs in juvenile justice settings require
13	careful attention to supporting youth in times of transition, such as when they enter custody
14	or return to their respective communities when released from custody; and
15	WHEREAS, it is imperative that high quality educational programs be provided in
16	juvenile justice facilities in order to help youth develop the academic and vocational skills
17	necessary to successfully transition to and succeed in high school, postsecondary education
18	institutions, and the workforce; and
19	WHEREAS, Louisiana's public education and juvenile justice systems would benefit
20	from careful assessment of the state's existing practices and from studies to ensure that the

1 best practices in education are implemented in detention centers, nonsecure and secure 2 facilities, and in times of transition in order for our youth to succeed in school and life. 3 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 4 establish the Education in Alternative Settings Study Commission to meet and make 5 recommendations to the legislature on actions necessary to provide the best possible 6 education to youth in juvenile justice settings. 7 BE IT FURTHER RESOLVED that the commission shall consist of the following 8 members: 9 The chairman of the House Committee on Education, or his designee. (1) 10 (2) One member of the House of Representatives appointed by the speaker of the 11 House. 12 (3) The chairman of the Senate Committee on Education, or his designee. 13 One member of the Senate appointed by the president of the Senate. (4) 14 The deputy secretary of the Department of Public Safety and Corrections, (5) 15 youth services, office of juvenile justice, or his designee. 16 (6) The state superintendent of education, or his designee. 17 The president of the Louisiana Juvenile Detention Association, or his (7) 18 designee. 19 (8) The secretary of the Department of Children and Family Services, or his 20 designee. 21 (9) One judge with jurisdiction over juvenile delinquency proceedings 22 designated by the Louisiana Council of Juvenile and Family Court Judges. 23 (10)One expert in juvenile justice and best practices in serving incarcerated youth 24 designated by the executive director of the Louisiana Center for Children's 25 Rights. 26 (11)One expert in special education rights designated by the director of the 27 Louisiana office of the Southern Poverty Law Center. 28 One expert in reentry and reintegration designated by the director of the (12)29 Institute for Public Health and Justice.

21	BE IT	FURTHER RESOLVED that the members of the commission shall serve	
22	without compensation.		
23	BE IT	FURTHER RESOLVED that a majority of the total membership shall	
24	constitute a q	uorum of the commission, and any official action by the commission shall	
25	require an affirmative vote of a majority of the quorum present and voting.		
26	BE IT	FURTHER RESOLVED that the commission shall conduct public meetings	
27	as it deems 1	necessary to fully and effectively perform its duties and accomplish the	
28	objectives and	d purposes of this Resolution, and may receive testimony and information	
29	relative to any	of the subjects of study enumerated in this Resolution.

1	BE IT FURTHER RESOLVED that the commission may seek and engage such		
2	counsel, research, assistance, and advice as may be obtained from any and all public and		
3	private sources, including but not limited to private research agencies, consulting groups,		
4	individuals, and organizations.		
5	BE IT FURTHER RESOLVED that the state superintendent of education or his		
6	designee shall be responsible for designating staff to assist the commission in performing		
7	its duties.		
8	BE IT FURTHER RESOLVED that, to the extent permitted by law, every officer,		
9	agency, board, commission, and department of the state, and every political subdivision and		
10	local officer, shall:		
11	(1) Provide aid, services, and assistance as may be requested by the commission.		
12	(2) Make available all facts, records, information, and data requested by the		
13	commission.		
14	(3) Allow commission members and persons providing consulting or advisory		
15	services to the commission reasonable access to juvenile justice facilities, as long as such		
16	access does not interfere with the security and stability of the facilities.		
17	(4) Cooperate with the commission in carrying out its functions and duties.		
18	BE IT FURTHER RESOLVED that the commission member designated by the		
19	chairman of the House Committee on Education shall convene the first meeting of the		
20	commission prior to August 1, 2015, at which meeting the commission shall elect a chair or		
21	co-chairs by vote of a majority of the members present.		
22	BE IT FURTHER RESOLVED that the commission may issue such interim reports		
23	as appropriate and shall submit a written report of its study findings and recommendations,		
24	including suggestions for proposed legislation, if any, to the House Committee on Education		
25	and the Senate Committee on Education no later than February 1, 2016.		
26	BE IT FURTHER RESOLVED that the commission shall terminate on December		
27	31, 2017.

Establishes the Education in Alternative Settings Study Commission to study and make recommendations to the legislature on education in juvenile justice settings and during transitions between the community and juvenile justice settings. Provides for commission membership, compensation, and duties. Provides that the commission shall submit a written report of its findings to the House and Senate education committees by Feb. 1, 2016. Provides that the commission shall terminate on Dec. 31, 2017.
