- 3 "vehicles"" and insert ""golf cart""

- On page 1, delete lines 13 through 20 in their entirety and on page 2, delete lines 1 through
- 8 in their entirety and insert in lieu thereof the following:
- 17 "B. The operation of a golf cart upon the public roads or streets of this state is prohibited except as otherwise provided in this Subsection:
- 19 (1) A golf cart may be operated only upon a parish road that has been designated by a parish or a municipal street that been designated by a municipality for use by golf cart. Upon a designation that a golf cart may be operated on a designated road or street, the responsible governmental entity shall post appropriate
- signage indicating that such operation is authorized.
- 24 (2) To cross a part of a public road or street where a golf course is 25 constructed on both sides of the public road or street if the Department of 26 Transportation and Development has reviewed and approved the location and design 27 of the crossing and installed any traffic control devices needed for safety purposes.
- C. A golf cart operated on a parish road or municipal street shall be equipped with efficient brakes, a reliable steering apparatus, safe tires, a rearview mirror, and
- red reflectorized warning devices in both the front and rear of the vehicle."

- "D. Any golf cart operated upon a parish road or municipal street shall be
  registered with the state"

- municipal government shall post appropriate signage or otherwise inform residents
- that such an ordinance exists and that it will be enforced within the parish or
- 17 municipal government's jurisdictional territory."

- 21 On page 2, line 28, after "Corrections," delete the remainder of the line and at the beginning
- of line 29, delete "vehicles, may adopt" and insert "public safety services, shall promulgate"
- 23 AMENDMENT NO. 14
- On page 3, at the end of line 3, after the period "." insert "Such rules and regulations shall
- 25 become effective no later than January 15, 2016."
