1	A CONCURRENT RESOLUTION
2	To express the sincere condolences of the Legislature of Louisiana upon the untimely death
3	of Vanessa Miller Prejean, an individual who faithfully served the Legislature of
4	Louisiana for thirty-two years, to commend her loyal service to both the Senate and
5	House of Representatives, and to celebrate a life well lived.

7	and employees of the Legislature of Louisiana first learned of the passing of a dear friend
8	and colleague, Vanessa Prejean, on January 2, 2015; and
9	WHEREAS, Vanessa was a personable woman brimming with kindness; she was the
10	genuine article, gracious and soft-spoken, and her sincere character put everyone who met
11	her at ease; and
12	WHEREAS, born on December 1, 1960, she was the only child of parents, John and
13	Dorothy Miller; reared in Baton Rouge and Port Allen, she graduated from Redemptorist
14	High School, matriculated at Louisiana State University, and in 1982, attained a bachelor of
15	science degree in Management and Administration; and
16	WHEREAS, her public service began in December of that year with employment by
17	the Louisiana Senate as a human resources manager under the tutelage of the comptroller,
18	Bill Curry; and later in September 2007, she moved to a human resources analyst position

1 with the Louisiana House of Representatives; and 2 WHEREAS, Vanessa did everything well; with her years of institutional knowledge 3 and attention to detail she focused on the task at hand, whether disseminating information 4 on employee benefits or managing payroll, human resources operations went smoothly; Vanessa handled each situation in a clear, concise, and courteous manner all the while 5 upholding the highest professional standards; and 6 7 WHEREAS, in her personal life, she enjoyed traveling, in particular jaunts to 8 New York City, highly anticipated adventures to the beach, and visits to relatives in 9 Kentucky; and 10 WHEREAS, Vanessa cherished her children and reveled in their accomplishments; 11 her son, Blake, is a construction manager, husband to Laura Beth, and father to William and 12 Camille; her daughter, Lindsey, has completed a degree in Kinesiology and will soon 13 complete an advanced nursing degree from Southeastern Louisiana University; and 14 WHEREAS, a high point in her life was the birth of her grandchildren, William 15 Blake and Camille Marie; she was the consummate grandmother doting on their every whim; 16 and WHEREAS, she taught her children the true meaning of devotion to family and of 17 18 the biblical commandment to honor one's father and mother; to honor Vanessa's last wishes 19 Blake, Laura Beth, Lindsey and her friend, Jared Ashford, have continued to care for Vanessa's elderly mother, Dot, who is ninety-three years of age and for Vanessa's pet dog, 20 21 Roxie; and WHEREAS, Vanessa loved her children with all her heart and instilled in them life's 22 tenets of inner strength, resiliency, and self-reliance; and 23 24 WHEREAS, although Vanessa Prejean left us all too soon, she leaves an indelible mark on the lives of her friends at the legislature; and 25 WHEREAS, Abraham Lincoln once said, "In the end, it's not the years in your life 26 27 that count.
