RETIREMENT/CONTRIBUTIONS: Provides relative to retirement contributions for employees of the city of Mandeville to the Municipal Employees' Retirement System

2	To enact R.S. 11:1869, relative to payment of employee contributions to the Municipal
3	Employees' Retirement System; to authorize payment of all or part of such
4	contributions by the city of Mandeville; and to provide for related matters.
5	Notice of intention to introduce this Act has been published
6	as provided by Article III, Section 13 and Article X, Section
7	29(C) of the Constitution of Louisiana.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 11:1869 is hereby enacted to read as follows:
10	§1869. Employee contributions; city of Mandeville
11	Notwithstanding any provision of law to the contrary, the city of Mandeville,
12	at its discretion, may pay to the system, from its own funds, all or a portion of the
13	employee contributions referenced in this Chapter and take appropriate legal and
14	administrative action to otherwise be in compliance with local, state, and federal
15	laws.
16	Section 2. This Act shall become effective on June 30, 2015; if vetoed by the
17	governor and subsequently approved by the legislature, this Act shall become effective on
18	June 30, 2015, or on the day following such approval by the legislature, whichever is later.

Abstract: Authorizes the city of Mandeville to pay all or part of the required employee contributions on behalf of its employees to the Municipal Employees' Retirement System (MERS).

<u>Present law</u> establishes MERS and sets forth required employee and employer contributions from participating members and employers.

<u>Present law</u> (R.S. 11:62(7)) establishes the following employee contribution rate ranges for members participating in MERS and authorizes the board of trustees of MERS to set the required rate within the applicable range:

- (1) For members of Plan A Not less than 9.25% nor more than 10%.
- (2) For members of Plan B Not less than 5% nor more than 6%.

<u>Present law</u> (R.S. 11:1865-1868) authorizes the following cities to pay MERS employee contributions on behalf of their employees: Monroe, Port Allen, Kenner, and Slidell.

<u>Proposed law</u> adds the city of Mandeville to this list of authorized employers.

Effective June 30, 2015.
