Current law stipulates qualifications of Commissioners on the LA Tax Commission.

Proposed Law retains current law and adds the requirement that commissioners must be licensed as a Certified General Appraiser or a Certified Residential Appraiser through the LA State Appraisers Board or the International Association of Assessing Officers.
