Requests the Department of Health and Hospitals, the Department of Education, the Medicaid managed care organizations, and representatives of the Whole Child Initiative to work together to develop a plan to implement the Whole School, Whole Community, Whole Child model developed by the United States Centers for Disease Control and Prevention.

A CONCURRENT RESOLUTION

2	To urge and request the Department of Health and Hospitals, the Department of Education,
3	the Medicaid managed care organizations, and representatives of the Whole Child
4	Initiative to work together to develop a plan to implement the Whole School, Whole
5	Community, Whole Child model developed by the United States Centers for Disease
6	Control and Prevention.
7	WHEREAS, Whole School, Whole Community, Whole Child (WSCC) is a
8	collaborative approach to learning and health developed by the United States Centers for
9	Disease Control and Prevention (CDC); and
10	WHEREAS, establishing healthy behaviors during childhood is easier and more
11	effective than trying to change unhealthy behaviors during adulthood; and
12	WHEREAS, research shows a link between the health outcomes of young people and
13	their academic success; and
14	WHEREAS, since 1987, CDC's coordinated school health approach has been the
15	blueprint for integrating health-promoting practices in schools, and coordinated school
16	health programs have helped to establish policies and practices in states, districts, and
17	schools across the nation and will see continued success with the expanded WSCC model;
18	and

1	WHEREAS, the WSCC model includes ten components: health education; nutrition
2	environment and services; employee wellness; social and emotional school climate; physical
3	environment; health services; counseling, psychological, and social services; community
4	involvement; family engagement; and physical education and physical activity; and
5	WHEREAS, the WSCC model meets the needs for greater emphasis on both the
6	psychological and physical environments as well as the ever-increasing and growing roles
7	that community agencies and families must play.
8	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
9	urge and request the Department of Health and Hospitals, the Department of Education, the
10	Medicaid managed care organizations, and representatives of the Whole Child Initiative to
11	work together to develop a plan to implement the WSCC model developed by the United
12	States Centers for Disease Control and Prevention.
13	BE IT FURTHER RESOLVED that the Department of Health and Hospitals host the
14	Department of Education, the Medicaid managed care organizations, and representatives of
15	the Whole Child Initiative in the development of the plan by providing meeting space,
16	calling the meetings, and staffing the meetings called to prepare the plan to be submitted to
17	the legislature.
18	BE IT FURTHER RESOLVED that the Department of Health and Hospitals be
19	responsible for preparing and delivering the plan to the legislature.
20	BE IT FURTHER RESOLVED that the Department of Health and Hospitals call the
21	first meeting no later than September 1, 2015.
22	BE IT FURTHER RESOLVED that the plan be submitted to the legislature no later
23	than January 15, 2016.
24	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
25	secretary of the Department of Health and Hospitals, the superintendent of the Department
26	of Education, the Medicaid managed care organizations, the Cecil J. Picard Center for Child
27	Development and Lifelong Learning, the Childhood and Family Learning Foundation, the

Louisiana Public Health Institute, and the United Way of Southeast Louisiana.
