LaSalle Parish clerk of court's office, the Ouachita Parish clerk of court's office, the Webster Parish clerk of court's office, or the Winn Parish clerk of court's office who is entitled to receive monthly benefits from the Louisiana Clerks' of Court Retirement and Relief Fund, who has at least twenty years of full-time service with the clerk of court's office in Avoyelles Parish, Bossier Parish, Caddo Parish, Caldwell Parish, Franklin Parish, Grant Parish, LaSalle Parish, Ouachita Parish, Webster Parish, or Winn Parish, and who is at least fifty-five years of age. The provisions of this Paragraph shall not apply to any other insurance, such as supplemental insurance, that an employee may elect to purchase.

**Abstract:** Provides for eligibility for payment of group insurance premium costs for employees retiring from certain clerks of court offices.

<u>Present law</u> requires the premium costs of group life and accidental death and dismemberment, group health, accident, dental, hospital, surgical, or other medical expense insurance to be paid in full by the clerk of court for the parishes of Bossier, Caddo, Caldwell, Franklin, Grant, LaSalle, Webster, and Winn, from the clerk's salary fund for any employee who is entitled to receive monthly benefits from the La. Clerks' of Court Retirement and Relief Fund and who retires with at least 20 years of full-time service and is at least 55 years of age.

<u>Proposed law</u> retains <u>present law</u> and extends requirements relative to the payment of group insurance premium costs to the clerks of court for the parishes of Avoyelles and Ouachita.
