EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of the proposed law.

REVENUE EXPLANATION

Proposed law may increase revenue within the Conservation Fund for the LA Department of Wildlife and Fisheries (LDWF) by an indeterminable amount per year. The revenue generated will be dependent upon the advertising contract(s) between LDWF and the entities with whom they enter into an agreement. This bill creates parameters and regulations for advertisements and sponsorships on state assets similar to what had been set forth in Act 41 of 2013 for the Department of Transportation and Development (DOTD). DOTD is currently collecting \$250,000 annually from State Farm. LDWF has 118 land vehicles that may be eligible for potential sponsorship.

Note: LDWF has not entered discussions with any potential sponsors at this time.
