HOUSE RESOLUTION NO. 47

ELECTIONS: Creates a special subcommittee to study certain matters relative to elections

1	A RESOLUTION	
2	To create and provide for a special subcommittee to be comprised of members of the	
3	Committee on Appropriations; the Committee on House and Governmental Affairs;	
4	the Committee on Judiciary; the Committee on Municipal, Parochial and Cultural	
5	Affairs; and the Committee on Ways and Means to examine and study certain	
6	matters relative to elections.	
7	WHEREAS, elections are a fundamental part of federal, state, and local government;	
8	they allow citizens to exercise their right to vote and thereby to have input into how their	
9	country, state, and community are governed; and	
10	WHEREAS, it is therefore appropriate to constantly examine our system of elections	
11	to determine how it might be improved; and	
12	WHEREAS, an area that should be examined is the number of elections conducted	
13	in the state during an election cycle; and	
14	WHEREAS, several officials who hold the same type of office run for election at	
15	different times; and	
16	WHEREAS, one possible way to reduce the number of elections would be to hold	
17	all elections for the same type of office at the same time; and	
18	WHEREAS, another area that should be examined is qualifying; and	
19	WHEREAS, present law provides that the opening of the qualifying period is less	
20	than two months before the date of the primary election for most elections; and	

1	WHEREAS, extending the time period between the opening of qualifying and the
2	election would provide voters with a better opportunity to learn about the candidates and to
3	make an informed vote; and
4	WHEREAS, however, there are a number of issues that should be examined if this
5	time period is to be extended significantly; and
6	WHEREAS, the cost of conducting elections is also a subject that should be
7	examined; and
8	WHEREAS, because the system of elections touches on subject matters that cross
9	the jurisdictions of a number of standing committees, a multidisciplinary approach is
10	advisable to examine this important topic.
11	THEREFORE, BE IT RESOLVED that the House of Representatives of the
12	Legislature of Louisiana does hereby create a special subcommittee of the Committee on
13	Appropriations; the Committee on House and Governmental Affairs; the Committee on
14	Judiciary; the Committee on Municipal, Parochial and Cultural Affairs; and the Committee
15	on Ways and Means to examine and study certain matters relative to elections.
16	BE IT FURTHER RESOLVED that the special subcommittee shall be composed of
17	eleven members appointed by the speaker: three members appointed from the House
18	Committee on Appropriations; two members appointed from the House Committee on
19	House and Governmental Affairs; two members appointed from the House Committee on
20	Judiciary; two members appointed from the House Committee on Municipal, Parochial and
21	Cultural Affairs; and two members appointed from the House Committee on Ways and
22	Means; the speaker shall designate the chairman of the special subcommittee.
23	BE IT FURTHER RESOLVED that the special subcommittee shall be responsible
24	for examining all matters relating to the system of elections in the state, including without
25	limitation consolidating the election of officials running for the same type of office,
26	extending the time period between the opening of the qualifying period and the election, and
27	the costs associated with conducting elections.
28	BE IT FURTHER RESOLVED that the special subcommittee shall make such
29	studies as it shall find necessary or appropriate to carry out its purposes; for the purposes of

30 conducting such studies, the special subcommittee may call upon the staffs of any

15	(10) The Louisiana Supreme Court.		
16	(11) The Louisiana District Judges Association.		
17	(12) Each recognized political party.		
18	(13) The Advocacy Center.		
19	(14) The Public Affairs Research Council of Louisiana.		
20	(15) The Council for A Better Louisiana.		
21	(16) The Louisiana Association of Business and Industry.		
22	(17) The Louisiana AFL-CIO.

24	BE IT FURTHER RESOLVED that the special subcommittee shall have the power		
25	and authority of a standing committee to hold hearings, require the production of books and		
26	records, and do all other things necessary to discharge its duties and responsibilities.		
27	BE IT FURTHER RESOLVED that the special subcommittee shall make a report		
28	of its findings and recommendations, including proposed legislation, to the House of		
29	Representatives no later than thirty days prior to the 2016 Regular Session; the special		

- 1 subcommittee may make other reports as it deems appropriate, but it shall also issue a report
- 2 no later than thirty days prior to the 2017 Regular Session if requested by the speaker.
 - BE IT FURTHER RESOLVED that the special subcommittee terminates on June 30,
- 4 2017.

Requires the special subcommittee to make a report of its findings and recommendations, including proposed legislation, to the House no later than 30 days prior to the 2016 R.S. Provides that the special subcommittee may make other reports as it deems appropriate, but shall issue a report no later than 30 days prior to the 2017 R.S. if requested by the speaker.

Provides that the special subcommittee terminates on June 30, 2017.
