- On page 2, between lines 17 and 18, insert the following:
- 12 "C. Governance. (1) In order to provide for the orderly planning, development, acquisition, construction, and effectuation of the services, 13 14 improvements, and facilities to be furnished by the district and to provide for the 15 representation in the affairs of the district of those persons and interests immediately concerned with and affected by the purposes and development of the district, the 16 district shall be managed by a nine-member thirteen-member board of 17 commissioners, referred to in this Section as the "board". The board shall be 18 19 comprised of members as follows:
- 20 (a) Two members shall be appointed by the state representative for House 21 District No. 29, one of whom shall be a representative of the business community.
- 22 (b) Two members shall be appointed by the state senator for Senate District No. 15.
- 24 (c) One member shall be appointed by the mayor-president of the parish of East Baton Rouge.
- 26 (d) One member shall be appointed by the member or members of the governing authority of the parish of East Baton Rouge who represent the district.
- 28 (e) One member shall be appointed by the owner of the largest parcel of land located within the district.
- 30 (f) One member shall be appointed by the state representative for House 31 District No. 61.

1 2	(g) One member shall be appointed by the state representative for House District No. 67.
3 4	(h) One member shall be appointed by the state representative for House District No. 101.
5 6	(i) One member shall be appointed by the state senator for Senate District No. 14.
7 8	(f) (i) The branch manager of a bank located within the district to be selected by a subcommittee formed by the board.
9 10	(g) (k) One representative of a civic association located within the district to be selected by a subcommittee formed by the board.
11 12 13	(2)(a)(i) Members serving pursuant to Subparagraphs (1)(a) through (e) (i) of this Subsection shall serve four-year terms after initial terms as provided by Item (ii) of this Subparagraph.
14 15 16	(ii) Two Three members shall serve an initial term of one year; two three shall serve two years; two three shall serve three years; and one two shall serve four years, as determined by lot at the first meeting of the board.
17 18 19	(b) Members serving pursuant to Subparagraphs (1)(f) and (g) (1)(j) and (k) of this Subsection shall serve at the pleasure of the subcommittee formed by the board."
