Dedicates the proceeds of the state sales tax collected on hotel rooms in Grant Parish to the Grant Parish Economic Development Fund

<u>Current law</u> imposes a 3.97% statewide sales tax on hotel/motel rentals in the state (.03% is collected for the statewide Tourism Promotion District).

<u>Proposed law</u> creates the Grant Parish Economic Development Fund into which proceeds of the 3.97% state sales tax on hotel/motel room rentals generated within Grant parish will be deposited. Interest will be deposited to state general fund and unused funds will remain in the fund. Upon appropriation to the Grant Parish Police Jury, the fund will be used to promote tourism within the parish.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Any initiation costs of this measure will be absorbed in the existing budget.

REVENUE EXPLANATION

According to the Department of Revenue, it collects sales tax on room rentals from only one hotel in Grant Parish, and considers the remittance amount confidential. This bill will reduce state general fund receipts by some small amount and increase statutory dedications by the same amount, to the Grant Parish Economic Development Fund created by this bill. To the extent that additional hotels or motels become operational in Grant Parish, the amount of the impact will increase. For illustration purposes, the Legislative Fiscal Office assumes this small amount of general fund dedication is \$5,000 per year.
