EXPENDITURE EXPLANATION

This measure may increase expenditures for the Cameron Parish Clerk Of Court's Office by approximately \$3,000 starting in fiscal year 2016 and increasing to approximately \$4,400 in fiscal year 2020.

According to information provided by an official with the Cameron Parish Clerk of Court's Office and our calculations, the proposed measure may increase expenditures in the Clerk's Office for retiree group insurance premiums by approximately \$3,000 starting in fiscal year 2016 and increasing to approximately \$4,400 in fiscal year 2020. These cost estimates include a 10% annual increase in premiums.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
