EXPENDITURE EXPLANATION

The proposed legislation will decrease state general fund expenditures. The proposed legislation abolishes several boards, commissions, and districts statewide.

This bill abolishes the active Commission on Addictive Disorders. Currently the commission is authorized to give members a per-diem, though the per-diem amount is listed as \$0 on the Division of Administration's list of Boards and Commissions. The commission currently has \$8,000 appropriated for travel reimbursement with expenditures of approximately \$4,400 in FY 15. In the event the commission is abolished, a nominal savings would occur.

The proposed legislation abolishes the Allen Parish and West Ouachita Parish Reservoir District Boards of Commissioners. The Legislative Fiscal Office attempt to reach an existing contact for the Allen Parish Reservoir District was unsuccessful. An attempt to contact the West Ouachita Parish Reservoir District was also unsuccessful, and as a result LFO considers both districts inactive. No savings will be derived by abolishing these districts, as neither has a listed budget on their profiles in the Division of Administration's list of Boards and Commissions.

This bill abolishes and officially transfers the boards of the Chennault Aviation and Military Museum of Louisiana and the Jean Lafitte Marine Fisheries Museum to the Secretary of State. The Legislative Auditor currently considers the Governing Board of the Jean Lafitte Marine Fisheries Museum inactive and it is currently listed as part of the Secretary of State's organizational structure in the Division of Administration's list of Boards and Commissions. There is no anticipated direct material effect on governmental revenues as a result of this measure. However, in the event any of these boards have available funds, they will be remitted to the state general fund.
