DOMESTIC VIOLENCE

RE1 NO IMPACT See Note

Page 1 of 1 Provides certain accommodations upon reasonable documentation presented by domestic abuse victims who lease residential dwellings. (8/1/15)

Proposed law applies only to a lease agreement for a residential dwelling or apartment with 4 or more separate residential dwellings. Under the proposed law, lease agreements cannot limit a tenant's call for law enforcement help in a domestic violence situation on the leased premises, or make tenants pay for such calls. Proposed law prohibits an owner from refusing to enter into a lease agreement or terminating a lease agreement solely because the person is a victim of domestic violence. Proposed law provides early termination with deposit return (if leased premises is not damaged) for a victim of domestic violence. Proposed law provides for the immediate eviction of a domestic abuse offender by the owner as well as grants the owner immunity from liability regarding the eviction proceedings. Proposed law provides for a "Certification of Domestic Abuse" form. Proposed law does not limit an owner from remedies provided under C.C.P. Art 4701 (Eviction of Tenants and Occupants) unrelated to domestic abuse. Proposed law provides for civil action for enforcement of rights granted in proposed law in state district court within one (1) year.


