4	WHEREAS, it is appropriate to commend Kara Gremillion for her outstanding
5	achievements as an extraordinary student and athlete; and
6	WHEREAS, Kara Gremillion is a 2015 graduate of St. Amant High School, where
7	she maintained a 4.31 weighted GPA and was a member of the National Honor Society; and
8	WHEREAS, she is the daughter of Ken and Claudia Gremillion of St. Amant,
9	Louisiana, and she is the sister of Courtney, Bo, and Bailey; and
10	WHEREAS, Kara is a member of Most Blessed Sacrament Church in Baton Rouge
11	and is also a mentor with the Operation First Base Outreach program, a community mission
12	project that shares the gospel, softball skills, and lunch with underserved youth in the
13	community; in her free time, she volunteers with a food bank and homeless shelters and
14	enjoys coaching youth softball teams; and
15	WHEREAS, Kara will attend the University of Louisiana at Lafayette, where she has
16	received a softball scholarship and an academic scholarship in recognition of her outstanding
17	achievements; and
18	WHEREAS, throughout her years at St. Amant High School, Kara won many awards
19	for her incredible athletic ability; she was the recipient of <i>The Advocate's</i> Athlete of the Year
20	Award for two consecutive years in 2014 and 2015, and was voted most valuable player in
21	volleyball, basketball, and softball; and

1	WHEREAS, throughout her four years at St. Amant High School, Kara has been an
2	exceptional volleyball, basketball, and softball player; and
3	WHEREAS, she helped lead the St. Amant High School volleyball team to the
4	Division I semifinals, and she also led the softball team to a 27-1 record and a spot in the
5	Class 5A semifinals; and
6	WHEREAS, as the senior shortstop for the St. Amant High School softball team,
7	Kara was named the 2015 Gatorade Louisiana Softball Player of the Year in recognition of
8	her high academic achievement and exemplary personal character, including volunteerism,
9	sportsmanship, and community leadership; she also had three straight Louisiana Sports
10	Writer Association Class 5A All-State softball distinctions; and
11	WHEREAS, Kara completed her high school softball performance with a .528
12	batting average, including .582 with runners in scoring positions, a .614 on-base percentage,
13	a .870 slugging percentage, seventeen home runs, twelve triples, forty-nine doubles, one
14	hundred nineteen runs batted in, and seventy stolen bases in seventy-three attempts in four
15	seasons as a starting player and lead-off batter for the St. Amant High School Gators softball
16	team; and
17	WHEREAS, in 2014 and 2015, she was named by NOLA.com as the preseason
18	player of the year and the postseason player of the year, and she was a three-time Louisiana
19	Softball Coaches Association First Team All-State selection; and
20	WHEREAS, she was also named the Metropolitan MVP Softball Player of the Year
21	in 2014 and 2015, and she played on the All-State volleyball team in 2014 and 2015; and
22	WHEREAS, Kara Gremillion merits a special measure of commendation for the
23	tremendous pride and honor that she brings to her family, friends, community, St. Amant
24	High School, and the state of Louisiana for her extraordinary academic achievements and
25	athletic ability and upon her many well-deserved awards and recognitions.
