AN ACT

2 To authorize and provide for the transfer of certain state property; to provide for the transfer of state properties in the parishes of East Baton Rouge and Rapides; to provide for 3 the property description; to provide for reservation of mineral rights; to provide 4 terms, conditions, and requirements; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 7 Section 1. The secretary of the Department of Health and Hospitals and the 8 commissioner of administration, notwithstanding any other provision of law to the 9 contrary, are hereby authorized and empowered to convey, transfer, assign, lease or 10 deliver any interest, excluding mineral rights, the state may have to all or any portion 11 of the following described parcel of property, including improvements, to the governing 12 authority of the Pineville Downtown Development District: 13 All those tracts or parcels which collectively as a group make up and constitute 14 the lands commonly known as the Central Louisiana State Hospital, designated 15 as State Lands and Building System (SLABS) Site Code Number 6-40-029, 16 Documents 1-96, inclusive, in the records of the State Land Office with said 17 parcels or tracts of land located in Township 4 North - Range 1 West and 18 Township 5 North - Range 1 West, City of Pineville, District North of the Red 19 River, Rapides Parish, Louisiana, being more particularly described as follows, 20 to-wit: 21 **Township 4 North - Range 1 West**

24	being located in parts of Section 10 & Section 11 of Township 4 North - Range

26	Subject to any rights, agreements, leases, encumbrances between the state of
27	Louisiana and all parties relating to the use, maintenance and preservation of
