1	AN ACT
2	To enact R.S. 33:2495.3, relative to municipal fire and police civil service; to provide
3	relative to persons selected for appointment to a position as an entry-level firefighter
4	in certain municipalities; to provide relative to the start of the working test period;
5	to require such persons to complete a fire training academy prior to the start of the
6	working test period; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 33:2495.3 is hereby enacted to read as follows:
9	§2495.3. Recruit and recruit period; certain municipalities
10	A. Notwithstanding any other provision of law to the contrary, in
11	municipalities with a population of not less than two hundred thousand persons and
12	not more than two hundred forty thousand persons as of the most recent federal
13	decennial census, no person selected for appointment to an entry-level position in the
14	classified service from the competitive firefighter employment list who has not
15	successfully completed formal training as required by Subsection B of this Section
16	shall begin the working test period. However, such person shall be employed by the
17	appointing authority and reported as a recruit, and shall immediately begin his formal
18	training.
19	B. Formal training for a person selected for appointment to an entry-level
20	position as a firefighter in the classified service shall mean the enrollment in and
21	successful completion of a fire training academy provided for through the appointing
22	authority. All persons selected for appointment to an entry-level position as a
23	firefighter in the classified service shall successfully complete the fire training
24	academy whether or not such person was certified as a Firefighter I in accordance

2	appointment.
3	C. The fire training academy provided for in Subsection B of this Section
4	shall be for a duration as determined by the appointing authority. Upon the
5	successful completion of the fire training academy, the recruit shall immediately
6	begin the working test period.
7	D. The appointing authority shall, within fifteen days, advise the board that
8	the recruit has successfully completed the fire training academy and has begun the
9	working test period as a probational firefighter.
10	E. Nothing in this Section shall be construed to require that a person selected
11	for appointment to an entry-level position as a firefighter in the classified service be
12	terminated if he fails to enroll in or successfully complete the fire training academy
13	as required by Subsection B of this Section.
