APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the DOTD in the matter of "Kayla Schexnayder and Emily Lagarde v. State of Louisiana, Department of Transportation and Development"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2016-3 2017 to be used to pay the consent judgment in the suit entitled "Kayla Schexnayder 4 and Emily Lagarde v. State of Louisiana, Department of Transportation and 5 Development"; to provide for interest; to provide for court costs; and to provide for 6 related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. A. The sum of Seven Hundred Ten Thousand Six Hundred Ninety-Three 9 and 47/100 (\$710,693.47) Dollars, plus six percent (6%) interest from May 29, 2008, 10 through November 13, 2013, plus judicial interest from November 14, 2013, until paid, plus 11 expert fees in the amount of Eighteen Thousand One Hundred Ninety and 01/100 12 (\$18,190.01) Dollars, in favor of plaintiff, Kayla Schexnayder, is hereby appropriated out 13 of the General Fund of the state of Louisiana for Fiscal Year 2016-2017 to be used to pay 14 the amended judgment in the suit entitled "Kayla Schexnayder and Emily Lagarde v. State 15 of Louisiana, Department of Transportation and Development", bearing Number 31,002 on 16 the docket of the Twenty-Third Judicial District Court, parish of Assumption, state of 17 Louisiana. 18 B. From the above monetary award amount payable to Kayla Schexnayder, the 19 amount of Four Thousand Six Hundred Ten and 15/100 (\$4,610.15) Dollars shall be paid to 20 the Department of Health and Hospitals for Medicaid reimbursement in the suit entitled HLS 16RS-174

State of 15 Louisiana, Department of Transportation and Development", bearing Number 31,002 on the 16 docket of the Twenty-Third Judicial District Court, parish of Assumption, state of Louisiana. 17 B. Monies awarded in this judgment to Emily Lagarde for future medical expenses 18 shall be payable from the Future Medical Care Fund established pursuant to R.S. 39:1533.2. 19 Payment for such future medical expenses shall be paid directly to the medical provider as 20 they are incurred pursuant to R.S. 13:5106(B)(3)(c). 21 Section 3.A. The sum of Four Thousand Five Hundred Twenty-Five and 86/100 22 (\$4,525.86) Dollars, in favor of the Assumption Parish Clerk of Court, is hereby 23 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2016-2017 to 24 be used to pay plaintiff's court costs in the suit entitled "Kayla Schexnayder and Emily 25 Lagarde v. State of Louisiana, Department of Transportation and Development", bearing 26 Number 31,002 on the docket of the Twenty-Third Judicial District Court, parish of 27 Assumption, state of Louisiana. 28 B. The sum of Four Hundred Forty-Four and 86/100 (\$444.86) Dollars, in favor of 29 the State of Louisiana Division of Administration, Office of Risk Management is hereby

appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2016-2017 to

- 1 reimburse the Office of Risk Management for a portion of plaintiff's court costs previously
- 2 advanced in this matter.
- 3 Section 4. The judgment provided for in Sections 1 and 2 hereof shall be deemed to
- 4 have been paid on the effective date of this Act and legal interest shall cease to run as of that
- 5 date.
- 6 Section 5. This Act shall become effective on July 1, 2016; if vetoed by the governor
- 7 and subsequently approved by the legislature, this Act shall become effective on July 1,
- 8 2016, or on the day following such approval by the legislature, whichever is later.
